Opportunity & Costs

Six months into the COVID-19 pandemic, one in three American adults had attended at least one telehealth appointment, marking an unprecedented level of remote care as telehealth moved from "niche" to "necessity".

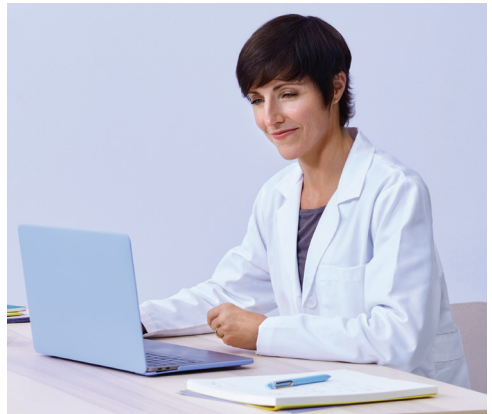
The COVID-19 Healthcare Coalition's Telehealth Impact Survey revealed that:

77%  of physicians believe telehealth has enabled them to deliver quality care for COVID-19 patients

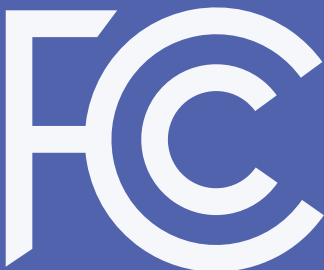
83%  have managed to deliver care in a more timely manner

89%  say it has enhanced chronic disease management

67%  believe patients' access to care has improved



That's not to say providers haven't encountered barriers to telehealth success. The most formidable obstacle, according to the survey? Nearly three in four physicians cited low or no reimbursements for telehealth services.



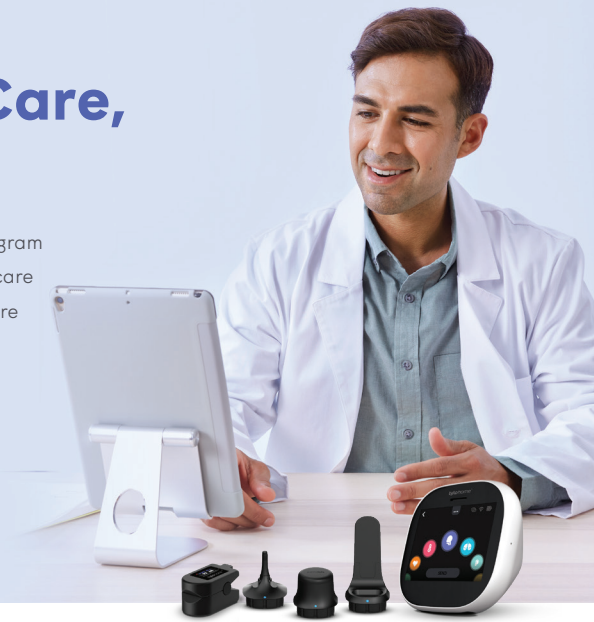
Cost concerns shouldn't stand in the way of the future of healthcare – and the good news is that help is on the way through the Federal Communications Commission's COVID-19 Telehealth Program. The application process is simple, quick, and requires no matching funds.

Here's how your organization can expand telehealth without fronting the costs.

Better Remote Care, Lower Cost

During its first round, the COVID-19 Telehealth Program provided \$200 million in funding to eligible healthcare networks for adopting or expanding connected care services like TytoCare.

While the program stopped accepting applications for the first funding round in late June 2020, the Consolidated Appropriations Act, 2021, allocated \$249.95 million for the program's second round, with applications set to begin soon.
