

Driving Rural Health Transformation with Hybrid Remote Clinics Powered by TytoCare



Rural communities are home to millions of Americans who often face the greatest challenges in getting the care they need. Long travel times, limited staff, and financial strain make it difficult for many people to access timely, high-quality healthcare close to home.

To help address these challenges, the Rural Health Transformation (RHT) Fund was created to support states in developing new, sustainable ways to deliver care in rural areas. The program will provide \$50 billion in funding, distributed over five years, to strengthen local healthcare systems, improve access to services, and ensure communities have the resources they need to thrive.

The RHT Fund, authorized under HR1, will be administered by the Centers for Medicare & Medicaid Services (CMS). States with approved transformation plans will receive annual funding from 2026 to 2030, helping them build stronger, more resilient healthcare networks that meet the unique needs of rural residents. Fifty percent of the funds will be distributed equally among approved states, with fifty percent being distributed at CMS discretion.

What Must States Include in Their Proposals?

To qualify for the Rural Health Transformation Fund, each state must include at least three activities from CMS's list of ten eligible priorities. These activities focus on strengthening rural healthcare through workforce development, access expansion, technology adoption, and measurable outcomes.

Remote micro clinics, such as TytoCare's Pro Smart Clinic, support and accelerate progress in seven of these key areas, helping states meet program goals with solutions that are practical, proven, and ready to scale.

With the Pro Smart Clinic, remote clinicians can perform complete medical-grade physical exams while on-site nurses, medical assistants, or telepresenters support the visit.

This model helps clinicians serve more patients each day, reduces travel time, and keeps staff connected and engaged, strengthening workforce capacity and job satisfaction.

Expanding Access and Equity

In many rural areas, seeing a doctor can mean hours of travel or long waits. TytoCare removes those barriers by bringing high-quality exams to the patient.

Using TytoCare's Pro Smart Clinic, clinicians can examine the heart, lungs, throat, ears, skin, and abdomen remotely, with live or recorded data shared instantly. Patients receive care quickly and conveniently, and local facilities can offer more services without additional clinicians on-site.

- Reduced patient travel by 2-6 hours per visit
- Achieved 98% visit resolution with no in-person follow-up required
- Increased access for Medicaid and uninsured populations by over 60%

Right-Sizing Rural Delivery Systems

Traditional approaches to expanding care, such as building new clinics or hiring additional staff, are costly and slow to implement. The Pro Smart Clinic enables a hub-and-spoke model that connects a central hospital or telehealth hub with smaller community sites.

These connected sites allow patients to receive the same level of care closer to home, while health systems use their existing teams more efficiently. The result: fewer emergency department visits for non-urgent issues, lower costs, and better use of local resources.

As the nation's largest rural health system, Sanford Health needed a scalable way to extend care across thousands of miles.

By integrating Tyto Care into over 80 rural clinics and critical access hospitals, Sanford enabled clinicians to conduct remote exams across more than 70 specialties.

Health System in Dallas:

Connecting Clinicians with Schools for On-Site Healthcare

In Dallas County, where 44% of children are on Medicaid and 33% uninsured, this health system sought a way to increase access while reducing strain on emergency departments.

After replacing costly telehealth carts (\$21K each) with TytoCare's Pro Smart Clinic, they expanded from a handful of schools to 239 campuses. School nurses use the Pro Smart Clinic to connect with remote clinicians for full diagnoses and prescriptions, helping prevent ER and UC visits and keeping kids in school.

Supporting Rural Heart Failure Patients at Home

For rural patients with chronic heart failure, long travel times and limited access to care centers created higher risks and frequent hospital readmissions. To close these gaps, Rochester Regional Health introduced a home-based monitoring program using TytoCare's mobile solution.

Community health workers visit patients at home and use Tyto Mobile to conduct remote exams with clinicians, ensuring timely follow-up and ongoing support after discharge. The approach improved outcomes, reduced hospital utilization, and provided consistent, connected care where patients needed it most.
